As per the order issued under G.O. (P) No. 80/85/TD dated 9-7-1985 and published as S.R.O. No.1048/85 Government of Kerala have remitted the registration charges for the execution of instruments of sale and lease to be executed in favour of the industries in the Cochin Export Processing Zone under the Registration Act, 1908 (Central Act XVI of 1908). The Government of India, Ministry of Commerce and Industry vide resolution No. 6/8/99 EPZ dated, 1st November, 2000 have converted the Cochin Export Processing Zone (CEPZ) into Cochin Special Economic Zone with effect from 1-11-2000. Hence the existing order has to be amended suitably.
