## INSTRUCTION

## Sub:- Streamlining of cargo movement - Instructions - Reg.

With a view to streamline movement of goods in and out of CSEZ and for maintenance of data thereof, the existing cargo challan system has been modified and Units shall, hereafter, follow the following procedure to obtain cargo challan from the CSEZ Gate Security:-

- a) The Unit user may login to the CSEZ Cargo Challan System and create a new cargo challan entry with details of the bill, like type of bill, bill number, bill date, vehicle number, etc and upload the document containing approval from the Customs for entry/exit of the specific goods. A running serial number will be generated on submission of the request, which can be used as a tracking number at the CSEZ Gate Security.
- b) The Security Officer at Gate, on request by the unit representative, shall verify the uploaded document with the details entered and if the document bears approval/endorsement of the Customs authorities, Cargo Challan shall be generated and handed over to the representative.
- c) In case there is any discrepancy in the details with the document uploaded like details mismatch, uploaded document does not have approval/endorsement of the Customs authorities, the official handling the Cargo Challan system at the CSEZ Gate Security shall reject the request in the system and record such incidents in a register and inform the same to the Customs Officer in charge of the Customs Gate.
- 2. The units shall upload scanned copy of the following documents against each of the bills mentioned below:-
