**Minutes of the 09th meeting (09/2026 series) of Unit Approval Committee for

(a) Confirmation of the minutes of the last meeting (08/2026) of the Approval Committee held on 31.08.2026.

The Committee was informed of the action taken on the decision of the Approval Committee meeting held on 31st August 2026 and confirmed the minutes of the previous UAC.

(b) Item wise decision on proposals included in agenda

Item No.1 Suo-Moto Cancellation of Letter of Permission in respect of M/s. Sara Bio Resources (India) Limited.

The proposal of **M/s. Sara Bio Resources (India) Limited** holds LOP No. 01/13/2017:PER:EOU:KR:CSEZ Dated 28/06/2017 for the manufacture and export of Processing of Coco Peat (Coir Pith). The unit is located at Sy. No. 90/1, 91/1, 90/3, Anchechomanagalli, Singatagere Hobli, Kadur, Chikkamangaluru - 577548 was examined by the committee and also noted that the unit has not commenced commercial operations and the validity of LoP Lapsed on 27.06.2019.

The Committee after due deliberations noted the status report furnished by the Office of the Commissioner of Customs, Export Promotion Cell, Mangalore-S75010 vide their Letter Dated 01/09/2026 that there are no dues/cases are pending against the said unit which was taken on records and further decided to suo-moto cancel the LoP No. 01/13/2017:PER:EOU:KR:CSEZ Dated 28/06/2017 in terms of Para 6.01 (h) of Handbook of Procedures 2023.
