**Minutes of the 1st Meeting of the Unit Approval Committee (01/2026 series) of Export Oriented Units in Kerala**

The first meeting (01/2026 series) of the Unit Approval Committee of Export Oriented Units in Kerala, constituted under Para 6.32 of Handbook of Procedures was held on 28<sup>th</sup> January 2026 at 10.30 A.M. in the Conference Hall of CSEZ Administrative Building, Kakkanad, Cochin through Hybrid mode. Besides the members, Shri N S Dev, Deputy Development Commissioner, and Assistant Development Commissioner, CSEZ were also present to assist the Approval Committee.

At the outset, the Development Commissioner and Chairman, Approval Committee welcomed the participants. After a brief introduction, each items included in the agenda were taken up and after deliberations, the following decisions were taken: -

- (i) **Confirmation of Minutes of the last meeting (06/2025) of the Approval Committee held on 18.12.2025.**

The Committee was informed of the action taken on the decisions of the Approval Committee held on 18.12.2025 and confirmed the minutes of the previous UAC.

***Item wise decisions on proposals included in the agenda:***

**1. Proposal (2 proposals)**

- C1. Request of M/s Adonai Industries Private Limited, Kollam for setting up a new unit under EoU Scheme for manufacture and export of Raw Cashew Nuts & Processed Cashew Nuts.**

The proposal of M/s Adonai Industries Private Limited, Kollam for setting up a new unit under EoU Scheme for manufacture and export of Raw Cashew Nuts & Processed Cashew Nuts, by taking on lease Building No. 11/431, Thudauannur, Kottarakkara, Kollam-691 536 and ₹130.00 lakh worth indigenous capital goods with projected export of ₹19500.00 lakh and Net Foreign Exchange earnings of ₹3180.00 lakh over a period of five years with employment generation for 30 persons was examined by the Committee. The Committee noted that the application is accompanied with all relevant documents as per Foreign Trade Policy 2023. Further, the Committee noted that the unit is exporting less than ₹50 crore annually and the investment made by them is also less than ₹50 crore. After due deliberations, the Committee approved the proposal.





**C2. Request of M/s Jollyflex Industries Private Limited, Ernakulam for setting up a new unit under EoU Scheme for manufacture and export of Industrial Hose, Hydraulic Hose, Dredging Hose-650mm\*2m, Dredging Hose 650mm\*12m Floating.**

The proposal of M/s Jollyflex Industries Private Limited, Ernakulam for setting up a new unit under EoU Scheme for manufacture and export of Industrial Hose, Hydraulic Hose, Dredging Hose-650mm\*2m, Dredging Hose 650mm\*12m Floating, at Plot Nos. EP 13,12, 11A., 37/205, KINFRA Petrochemical Park, Ambalamugal, Kochi - 682 302 with projected export of ₹18160.00 lakh, Capital goods investment of ₹2448.50 lakh (Import - ₹2343.50 and Indigenous - ₹105 lakh) and Net Foreign Exchange earnings of ₹12803.14 lakh over a period of five years with an employment generation for 67 persons was examined by the Committee. The Committee noted that the application is accompanied with all relevant documents as per Foreign Trade Policy 2023. Further, the Committee noted that the unit is exporting less than ₹50 crore annually and the investment made by them is also less than ₹50 crore. After due deliberations, the Committee approved the proposal.
