At the outset, the Development Commissioner welcomed the participants. After a brief introduction, each items included in the agenda were taken up and after due deliberations, the following decisions were made:-

Item wise decisions on proposals included in agenda:

(a) Confirmation of the minutes of the 13th meeting of the Approval Committee (13/2025 series) held on 31.07.2025.

The Committee was informed of the actions taken on the decision of the Approval Committee meeting held on 31st July 2025 and confirmed the minutes of the previous UAC.

- 3.1 Proposal for setting up new units (1 proposal)
- 3.1 (i) Application of M/s Mera Fabrics for setting up a new Unit in KIADB Textiles SEZ, Hassan.

The proposal of M/s Mera Fabrics for setting up a unit in KIADB Textiles SEZ, Hassan for carrying out the authorized activities viz. Bath Robe, Bath Towel/Hand Towel/Face Towel, Bath Mat, Bath Towel Colors, Bed Runners, Cushion Covers, in an area of 1359.00 sq.mtrs, with projected export of ₹4762.39 lakh, Capital Goods Investment of ₹3611.31 lakh (Import: ₹1585.65 lakh & Indigenous: ₹2025.66 lakh) and Net Foreign Exchange earnings of ₹3176.74 lakh over a period of five years with an employment generation of 40 persons, was examined by the Committee.
