## MINUTES OF THE UAC MEETING OF SEZS IN KARNATAKA HELD ON 30.10.2025.

Minutes of 19<sup>th</sup> meeting (19/2025 series) of Unit Approval Committee of SEZs in Karnataka held on 30.10.2025 through video conference.

Besides the members, Shri. Harish Varmaa. P, IDES, Joint Development Commissioner, Shri Harshanand G.A, IRS, Deputy Development Commissioner and Assistant Development Commissioners of various SEZs in Karnataka were also present to assist the Approval Committee.

At the outset, the Development Commissioner welcomed the participants. After a brief introduction, each items included in the agenda were taken up and after due deliberations, the following decisions were made:-

## Item wise decisions on proposals included in agenda:

(a) Confirmation of the minutes of the 18<sup>th</sup> meeting of the Approval Committee (18/2025 series) held on 17.10.2025.

The Committee was informed of the actions taken on the decision of the Approval Committee meeting held on 17<sup>th</sup> October 2025 and confirmed the minutes of the previous UAC.

- 3.1 Proposal for setting up new units (1 proposal)
- 3.1 (i) Application of M/s NICOMATIC India Electronics Private Limited for setting up a new unit in KIADB Aerospace SEZ, Bangalore.

The proposal of M/s NICOMATIC India Electronics Private Limited for setting up a unit in KIADB Aerospace SEZ, Bangalore for carrying out authorized activities viz., manufacturing of High-performance electronics connectors used for joining electronics circuits in defence and aerospace applications, in an area of 6070.28 sq.mtrs, with projected export of ₹34,633.32 lakh, capital goods Investment of ₹1300.00 lakh (Import: ₹400.00 lakh & Indigenous:₹900.00 lakh) and Net Foreign Exchange earnings of ₹31,779.73 lakh over a period of five years with an employment generation of 83 persons, was examined by the Committee. After due deliberations, the Committee approved the proposal in terms of the provisions contained in Rule 18(2) of SEZ Rules 2006.

- 3.2 Proposal for revision of approved project parameters (2 proposals)
- 3.2 (i) Request of M/s Rohde & Schwarz India Private Limited, a unit in Manyata Embassy Business Park SEZ for addition of space and revision of approved project parameters

The Committee after due deliberations, approved the proposal of the unit for addition of space admeasuring 1687.95 sq.mtrs with revision of approved project parameters, as it conforms to the requirement of Rule 19(2) of SEZ Rules, 2006.

3.2 (ii) Request of M/s APTIV Components India Private Limited, a unit in Brigade Properties Pvt. Ltd. SEZ for change of entrepreneur M/s APTIV Components India Private Limited with M/s ASUX Safety Components India Private Limited by way of Order for De-Merger from Regional Director (Ministry of Corporate Affairs).

The Committee examined the proposal of the unit for approval of change in entrepreneur from "APTIV Components India Private Limited" to "ASUX Safety Components India Private Limited", as per order of scheme of amalgamation or merger dated 18.09.2025. After due deliberations, Committee approved the proposal, as it conforms to the requirement of Rule 19(2) of SEZ Rules 2006 read with Instruction No.109 dated 18.10.2021 issued by DoC.

- 3.3 Miscellaneous proposals (2 proposals)
- 3.3 (i) Request of M/s 7-Eleven Corporate Services India LLP a unit in Milestone Buildcon SEZ for setting up of Cafeteria.

The Committee after due deliberations approved the proposal of the unit for setting up of Cafeteria for exclusive use of their employees, as per Instruction No.95 dated 11.06.2019, subject to the condition that the services provider shall not be entitled for any duty/tax benefits in this regard. The details are as under:-

3.3 (ii) Request of M/s West Pharmaceutical Packaging India Private Limited a unit in Embassy Tech Village SEZ for procurement of duty free iPhone devices for their authorized operations.

The Committee after due deliberations, approved the proposal of the unit for procurement of duty free iPhones devices (300 Nos.) for their authorized operations as it conforms to the Rule 27 of SEZ Rules, 2006, subject to the condition that the unit shall execute an additional BLUT for the value equivalent to the duty of imported mobiles.
