Minutes of the 3rd Meeting of the Unit Approval Committee (03/2026 series) of Export Oriented Units in Kerala

The 3rd meeting (03/2026 series) of the Unit Approval Committee of Export Oriented Units in Kerala, constituted under Para 6.32 of Handbook of Procedures was held on 10th march 2026 at 10.30 A.M. in the Conference Hall of CSEZ Administrative Building, Kakkanad, Cochin through Hybrid mode. Besides the members, Shri N S Dev, Deputy Development Commissioner, and Assistant Development Commissioner, CSEZ were also present to assist the Approval Committee.

At the outset, the Development Commissioner and Chairman, Approval Committee welcomed the participants. After a brief introduction, each items included in the agenda were taken up and after deliberations, the following decisions were taken:

(i) Confirmation of Minutes of the last meeting (02/2026) of the Approval Committee held on 13.02.2026.

The Committee was informed of the action taken on the decisions of the Approval Committee held on 13.02.2026 and confirmed the minutes of the previous UAC.

Item wise decisions on proposals included in the agenda:

1. Proposal (1 proposals)

C1. Request of M/s Affco Exim Private Limited, Kollam for conversion of the existing DTA unit into 100% EOU Scheme for the manufacture and export of Processed Cashew Kernels (Whole, Broken & Roasted).

The proposal of M/s Affco Exim Private Limited, Kollam for conversion of existing DTA unit into EoU Scheme for the manufacture and export of Processed Cashew Kernels-Whole, Processed Cashew Kernels- Broken and Processed Cashew Kernels- Roasted at 30/2674/1458, Rayarumukku, Kallumthazham, Kilikolloor P.O., Kollam, Kerala with indigenous capital goods requirement of ₹116.85 lakh, projected export of ₹15087.97 lakh and Net Foreign Exchange earnings of ₹4496.20 lakh over period of five years with an employment generation for 28 persons was

examined by the Committee. The Committee noted that the application is accompanied with all relevant documents as per Foreign Trade Policy 2023. Further, the Committee noted that the unit is exporting less than ₹50 crore annually and the investment made by them is also than ₹50 crore. After due deliberations, the Committee approved the proposal.
