Besides the members, Shri N S Dev, Deputy Development Commissioner, Shri Laloo P G, Specified Officer, CSEZ and Assistant Development Commissioners of various SEZs in Kerala were also present to assist the Approval Committee.

At the outset, the Development Commissioner and Chairman, Approval Committee welcomed the participants. After a brief introduction, each items included in the agenda were taken up and after deliberations, the following decisions were taken: -

(i) Confirmation of Minutes of the last meeting (14/2025) of the Approval Committee held on 31.07.2025.

The Committee was informed of the action taken on the decisions of the Approval Committee held on 31.07.2025 and confirmed the minutes of the previous UAC.

Item wise decisions on proposals included in the agenda:

- 3.1 PROPOSALS FOR SETTING UP OF NEW UNITS (6 PROPOSALS)
- 3.1(i) Application of M/s Kalki Communication Technologies Private Limited for setting up a unit in Cochin SEZ.

The proposal of M/s Kalki Communication Technologies Private Limited for setting up a new unit in Cochin Special Economic Zone, Cochin for carrying out the authorized activities viz., "Information Technology (IT) Consulting and Support Services (998313/8313), Information Technology (IT) Design and Development Services (998314/8314) and Hosting and Information Technology Infrastructure provisioning service (998315/8315) in an area of 1513.95 sq,mtr. with projected export of ₹13160.39 lakh, Capital Goods Investment of ₹816.95 lakh (Import: ₹338.75 lakh & Indigenous: ₹478.20 lakh) and Net Foreign Exchange earnings of ₹12396.89 lakh over a period of five years with an employment generation for 150 persons was examined by the Committee. After due deliberations, the Committee approved the proposal in terms of Rule 18(2) of SEZ Rules 2006.

3.1(ii) Application of M/s Hina Textiles Mills Pvt. Ltd, for setting up a unit in Vallarpadam Special Economic Zone, Cochin (FTWZ unit).

The proposal of M/s Hina Textiles Mills Private Limited for setting up a new unit in Vallarpadom Special Economic Zone, Ernakulam for carrying out the authorized activities viz., Storage & Warehousing (996729/742) and Value Added Services (Packing and Labelling) (998599/862) in an area of 464.51 sq,mtr. with projected export of ₹1680.00 lakh, capital goods Investment of ₹10.00 lakh (Indigenous) and Net Foreign Exchange earnings of ₹1672.00 lakh over a period of five years with an employment generation for 5 persons was examined by the Committee. After due deliberations, the Committee approved the proposal in terms of Rule 18(2) of SEZ Rules 2006.

3.1(iii) Application of M/s Three Mount Impex Private Limited, for setting up a unit in Vallarpadam Special Economic Zone, Cochin (FTWZ unit).

The proposal of M/s Three Mount Impex Private Limited for setting up a new unit in Vallarpadom Special Economic Zone, Ernakulam for carrying out the authorized activities viz., Storage & Warehousing (996729/742) and Value Added Services (Packing and Labelling) (998599/862) in an area of 464.51 sq,mtr. with projected export of ₹1682.64 lakh, Capital Goods Investment of ₹10.00 lakh (Indigenous) and Net Foreign Exchange earnings of ₹1676.64 lakh over a period of five years with an employment generation for 5 persons was examined by the Committee. After due deliberations, the Committee approved the proposal in terms of Rule 18(2) of SEZ Rules 2006.

3.1(iv) Application of M/s Singularis Future Serv India Private Limited for setting up of a unit in Infopark SEZ Phase I, Ernakulam.

The proposal of M/s Singularis Future Serv India Private Limited for setting up a new unit in Infopark Special Economic Zone Phase-I, Ernakulam for carrying out the authorized activities viz., Information Technology consulting and support Services (998313/8313), Information Technology design and development Services (998314/8314), Hosting and Information Technology Infrastructure Provisioning Services (998319/8319) and Other Information Technology services not classified Elsewhere (998315/8315) in an area of 139.35 sq,mtr. with projected export of ₹6357.06 lakh, capital goods Investment of ₹98.00 lakh (Import: ₹5.00 lakh & Indigenous: ₹93.00 lakh) and Net Foreign Exchange earnings of ₹6552.06 lakh over a period of five years with an employment generation for 51 persons was examined by the Committee. After due deliberations, the Committee approved the proposal in terms of Rule 18(2) of SEZ Rules 2006.

3.1(v) Application of M/s Seaker Systems Private Limited for setting up a unit in Infopark SEZ Phase-I, Ernakulam.

The proposal of M/s Seaker Systems Private Limited for setting up a new unit in Infopark Special Economic Zone Phase-I, Ernakulam for carrying out the authorized activities viz., Programming Services- Software Development (998314/8424), Systems analysis Services (998314/8422), Systems and software consulting services (998314/8421) and Systems Design Services (998314/8423) in an area of 730.21 sq,mtr. with projected export of ₹4090.00 lakh, capital goods Investment of ₹60.00 lakh (Import: ₹5.00 lakh & Indigenous: ₹55.00 lakh) and Net Foreign Exchange earnings of ₹4085.00 lakh over a period of five years with an employment generation for 32 persons was examined by the Committee. After due deliberations, the Committee approved the proposal in terms of Rule 18(2) of SEZ Rules 2006.



3.1(vi) Application of M/s Rowther Engineering Consultancy for setting up of a Unit in Infopark SEZ Phase-I, Ernakulam.

The proposal of M/s Rowther Engineering Consultancy for setting up a new unit in Infopark Special Economic Zone Phase-I, Ernakulam for carrying out the authorized activities viz., Information Technology (IT) Consulting and support Services (998313/8313), Information Technology (IT) design and development Services (998314/8314), Engineering services for Building Projects (998332/8332), Engineering services for industrial and manufacturing projects (998333/8333) and Project management services for construction projects (998339/8339) in an area of 147.99 sq,mtr. with projected export of ₹1417.00 lakh, Capital Goods Investment of ₹72.00 lakh (Import: ₹10.00 lakh & Indigenous: ₹62.00 lakh) and Net Foreign Exchange earnings of ₹1397.00 lakh over a period of five years with an employment generation for 26 persons was examined by the Committee. After due deliberations, the Committee approved the proposal in terms of Rule 18(2) of SEZ Rules 2006.

- 3.3 PROPOSALS FOR CHANGE IN SHAREHOLDING PATTERN/NAME/BOARD OF DIRECTORS ETC. (4 PROPOSALS)
- 3.3(i) M/s Genpro Research Private Limited, a unit in Infopark SEZ Phase-II Intimation regarding change in name and Board of Directors.

3.4(iii) Cancellation of Letter of Approval of M/s Conscience Business Solutions Private Limited, a unit in Electronics Technology Park SEZ, Phase -III, Thiruvananthapuram.

The Committee examined the item in detail and noted the following:-

- a) The validity of LoA No. KL:15:10:Techno(III):2J1 dated 24.10.2014 issued to M/s Conscience Business Solutions Private Limited has been expired on 08.10.2020
- b) The unit not submitted application for renewal of the validity of the LoA or submitted application for exit from the scheme.
- c) A show-cause notice was issued to the unit on 06.01.2020 for non-submission of APR and other SEZ compliances. During the personal hearing, the Managing Director of the unit assured compliance of all the formalities within 10 weeks which was not done.
- d) It is also noted that the Managing Director recently informed that they are searching for a suitable space outside the SEZ to shift their company after exiting from the Scheme. However, no application for exit has been submitted till date.

After due deliberations, the Committee decided to issue Show-Cause Notice to the company for cancellation of LoA as per Section 16 of the SEZ Act 2005.
