At the outset, the Development Commissioner and Chairman, Approval Committee welcomed the participants. After a brief introduction, each items included in the agenda were taken up and after deliberations, the following decisions were taken: -

(i) Confirmation of Minutes of the last meeting (20/2025) of the Approval Committee held on 30.10,2025.

The Committee was informed of the action taken on the decisions of the Approval Committee held on 30.10.2025 and confirmed the minutes of the previous UAC.

Item wise decisions on proposals included in the agenda:

- 3.1 PROPOSALS FOR SETTING UP OF NEW UNITS (3 PROPOSALS)
- 3.1 (i) Application of M/s John &Smith Solutions LLP for Setting up a Unit in SmartCity (Kochi) SEZ, Ernakulam.

The proposal of M/s John &Smith Solutions LLP for setting up a new unit in SmartCity (Kochi) Special Economic Zone, Kakkanad for carrying out authorized activity viz., Information Technology Consulting and Support Services (998313/8313), Information Technology Design and Development Services (998314/8314), Hosting and Information Technology Infrastructure Provisioning Services (998315/8315), IT Infrastructure and Networking Management Services (998316/8316), Other information services nowhere else classified (998319/8319) and Technical Testing and Analysis Services (998346/9983) in an area of 752.24 sq.mtr. with projected export of ₹592700 lakh, Capital Goods of ₹499.50 lakh (Indigenous: ₹74.92 lakh, Import: ₹424.58 lakh) over a period of five years with an employment generation for 30 persons was examined by the Committee. The proposal of M/s Gladius and Schild LLP for setting up a new unit in Infopark Phase-I Special Economic Zone, Kakkanad for carrying out authorized activity viz., Information Technology (IT) consulting and support services (8313), Information Technology (IT) Design and development services (8314), Hosting and information technology infrastructure provisioning services (8315) and Other Information Technology Services n.e.c (83132) in an area of 85.98 sq.mtr. with projected export of ₹767.00 lakh, Capital Goods of ₹71.00 lakh (Indigenous) over a period of five years with an employment generation for 20 persons was examined by the Committee. After due deliberations, the Committee approved the proposal in terms of Rule 18(2) of SEZ Rules 2006.
