TENDER NOTICE

In SEEPZ-SEZ, there are large numbers of Gems & Jewellery Manufacturing units. These units have their own methods of recovery of precious metal from the waste. The waste water from these units which may contain particles of precious metal gets accumulated in the form of investment powder.

Sealed Tenders are invited from Authorized Refineries for disposal of accumulated investment powder in the SEEPZ-SEZ on the following terms and conditions:-

- 1> The investment powder waste will be removed by the approved bidder on '*as is where is condition*' out of SEEPZ-SEZ.
- 2> No spreading or drying of the investment powder waste in the Zone will be allowed.
- 3> The successful bidder shall pay value at the prevailing market rate for the precious metal content in the investment powder waste as ascertained from the sample test carried out at the Govt. Mint., and applicable Customs duties thereon.
- 4> The sample shall be drawn in the presence of the successful bidder.
- 5> The bidders should indicate his/ their cost or charges for the above work as a percentage of the precious metal content ascertained by the Govt. Mint. This will form the basis of comparison of tender all other thing being same across tenders.
- 6> The bidder should have his / their own refining facility and should submit requisite supporting documents regarding the same such as copy of Industrial Approval, certificate granted by concerned State Pollution Control Board/Central Pollution Control Board Registration for hardware and H.W. Transport & Licence issued by concerned State PCB/CPCB, and any other supporting documents, etc.
- 7> **The bidder should ensure that cost or charges for the above work is quoted only as a percentage of the precious metal content ascertained by Government Mint as specified in condition No. 5 herein.**

- 8> **In case the bidder whose tender is accepted by the Competent Authority fails to carry out the work within the time limit specified in the Work Order, apart from forfeiture of EMD, penalty shall be levied @ Rs. 1000/- per day for the delayed period.**
- 9> An unclear / incorrectly worded tender will be liable to be rejected.
- 10> The sealed tender should be submitted on or before **25.03.2013** upto 15.00 hrs.
