The undersigned is directed to say that it is proposed to fill up one vacancy on deputation basis in the grade of Stenographer Grade I Group 'B' - Gazetted) in the Pay Band of Rs.9300-34800 (PB-2) with Grade Pay of Rs.4200/- in the Office of the Development Commissioner, Sub-Office Bangalore. The eligibility criteria for appointment on deputation basis for the post is indicated as follows:


- (i) Holding analogous posts on regular basis in the Central Government ; or
- (ii) with eight years' regular service as Stenographer Grade III in the Pay Scale of Rs.4000-100-6000/- (Pre - revised)

2. It is requested that applications, in the given Proforma (Annexure I) in duplicate, of the eligible and willing officers who could be relieved in the event of selection, alongwith the following documents, may please be forwarded to this office within 60 days from the date of issue of this Office Memorandum.

- (a) Complete and up-to-date confidential reports for the last five years, in original or attested Photostat copy thereof by an officer not below the rank of Under Secretary to the Government of India.
- (b) Integrity Certificate/Vigilance Clearance
- (c) Details of major/minor penalties imposed during the last 10 years (if no penalties have been imposed, it should be stated)

3. Applications received after the last date or without the confidential reports or other relevant documents or otherwise found incomplete will not be considered.

4. The appointment will be on deputation basis. The period of deputation shall ordinarily not exceed 3 years. The selected officers will have the option to draw his/her grade pay plus deputation (duty) allowance, in accordance with Ministry of Finance OM No.10/24/E.III/60 dated 4th may 1961 as amended from time to time.
