Subject: Roll out of Indian Customs EDI System-(ICEGATE for Imports and Exports at SEZs) – reg.

Attention of all the Units / Developer/Co-developers, under the Jurisdiction of Development Commissioner, CSEZ, Kakkanad, is invited to the fact that the necessary enablement has been carried out by DG System, CBIC and the sites under their zonal jurisdiction has been created on the customs EDI system for the purpose of Imports, Exports, DTA Procurement/Sale, Intra and Inter SEZ Transactions etc.

2. Accordingly, all concerned are requested to use ICEGATE system henceforth for filing documents for import and exports i.e. BEs and SBs DTA Procurement/Sale, Intra and Inter SEZ Transactions w.e.f. 1st of July 2024. As a consequence, electronic filing of documents through the erstwhile NSDL online for Imports and Exports would discontinue from 1st of July, 2024. In case of any clarification in this regard, Shri.
