

Instruction No. 6/2020

In order to contain the spread of Covid-19 and also to ensure that no case goes undetected and unattended in SEZs under the jurisdiction of this office, it is decided to appoint Nodal officers in every SEZ under Office of the Development Commissioner, Cochin Special Economic Zone. Accordingly, all Specified Officers/Authorised Officers shall be the Nodal officers in their respective SEZs (Details given in Annexure).
